**MOTION OF NON-PARTIES DR. BETTY PRINCE AND MOSAID TECHNOLOGIES  
INC. FOR AN EXTENSION OF TIME TO SEEK *IN CAMERA* PRODUCTION OF  
DOCUMENTS**

Pursuant to the Fourth Revised Scheduling Order entered in this matter on February 21, 2003, the last day to file motions for *in camera* treatment for proposed trial exhibits is April 11, 2003. Dr. Betty Prince, who is not a party to this FTC proceeding, and MOSAID Technologies Inc. ("MOSAID"), which is also not a party to this FTC proceeding, hereby respectfully request an extension of time until April 18, 2003 to seek *in camera* treatment for certain trial exhibits proposed by Rambus and counsel to the FTC. Counsel to the FTC has indicated that they do not oppose Dr. Prince's and MOSAID's motion for an extension of time and counsel for Rambus does not oppose a motion for an extension until Monday, April 14th.


Dr. Prince, who is on the Board of Directors of MOSAID, produced certain documents electronically in this proceeding, pursuant to a subpoena by Rambus. Upon information and belief, the parties to this proceeding subsequently made paper copies of Dr. Prince's electronically-produced documents, and counsel to Rambus has indicated that Rambus proposes to use various of these documents at the hearing in this matter.

Dr. Prince's documents may contain material that is confidential and proprietary to both Dr. Prince and MOSAID. Because Dr. Prince and MOSAID do not have access to the specific

documents proposed by Rambus for use at the hearing, Rambus counsel agreed to provide the documents to Dr. Prince and MOSAID. Dr. Prince and MOSAID thus respectfully request additional time in which to review the documents Rambus sent via facsimile on April 10, 2003 at 7 o'clock PM, and to seek *in camera* treatment, to the extent appropriate.




