SECOND UNOPPOSED MOTION FOR EXTENSION OF TIME FOR MCWANE, INC.
TO FILE RESPONSE TO SIP INDUSTRIES' MOTION TO QUASH

COMES NOW MCWANE, INC., BY AND THROUGH ITS COUNSEL AND MOVES
AS FOLLOWS:

1. On or about March 9, 2012, counsel for respondent McWane, Inc. ("McWane") received service via registered mail of SIP Industries' ("SIP") Motion to Quash McWane's Subpoena Duces Tecum ("Motion to Quash").

2. On March 20, 2012, McWane filed an Unopposed Motion for Extension of Time to File its Response to SIP's Motion to Quash, requesting an extension until March 30, 2012. On March 20, 2012, Judge Chappell granted McWane's motion.

3. Counsel for SIP and McWane continue to engage in negotiations regarding the scope of McWane's specifications and objections by SIP thereto. To facilitate those negotiations, McWane requests an additional seven (7) days in which to file a response to SIP's Motion to Quash, should McWane and SIP be unable to resolve any remaining issues.

4. Therefore, McWane requests that this Court grant it until April 6, 2012 to file a response to SIP's Motion to Quash, in order to afford McWane and SIP sufficient time to negotiate.

5. Undersigned counsel represents that he has conferred with SIP's counsel and that SIP's counsel does not object to the proposed extension.
