#### <u>COMPLAINT</u>

The Federal Trade Commission, having reason to believe thateSamd BadLe (collectively, "Respondent's) have violated the provisions of the Federal Trade Commission Act, and it appearing to the Commission that this proceeding is in the public interest, alleges:

1. Respondent Son Lalso known as Sonrbe, owns and does business as Recreational

Individually or in concert with others, he controlled, or had the authority to control, or participated in the acts and practices leged in this complaint. His principal office or place of business is 1401 East Road, #C, AnaheimCalifornia92805.

- 3. Using the fictitious business names listed aboves pondents haved vertised offered for sale, sold, and distributed products to consume duding Infinity and Olympus Protrampolines
- 4. The acts and practices Respondents alleged in this complaint have been in or affecting commerce, as "commerce" is defined in Section 4 of the Federal Trade Commission Act.

#### Course of Conduct

- 5. Respondents have advertised, offered for sale, and institution and Olympus Pro trampolines online through the ollowing websites Infinity Trampolines (www.infinitytrampolines.com, Happy Trampoline (www.appytrampoline.com, and Trampoline Jumpers (www.trampolinejumpers.com, allesWebsites). Depending on the model, annifinity trampoline costs between \$798.00 and \$2898.00 and an Olympus Pro trampoline costs between \$799.00 and \$4895.00.
- 6. All of the Sales Websites have prominentlyplayed the Trampoline Safety of America logo. The Infinity Trampoline website also displaylogos for the Bureau of Trampoline Review and Top Trampoline Review These logs linked to their respective website the "Review Websites", Trampoline Safety of America (www.trampolinesafetyofamerica.com), Bureau of Trampoline Review (www.bureauoftrampolinereview.com), and Top Trampoline Review (www.toptrampolinereview.com), which have purported to provide pective purchasers with objective information about ampolines including unbiased expert reviews of specific brands and models and ratings based on safety, performance, and other attributes
- 7. The Review Webses have recommender finity and Olympus Pro trampolines.
- 8. Respondent Son Le ownthe Sales Websites and the Review Websitesspondents Son Le andBao Le control the content of the Sales Websites and the Review Websites.
