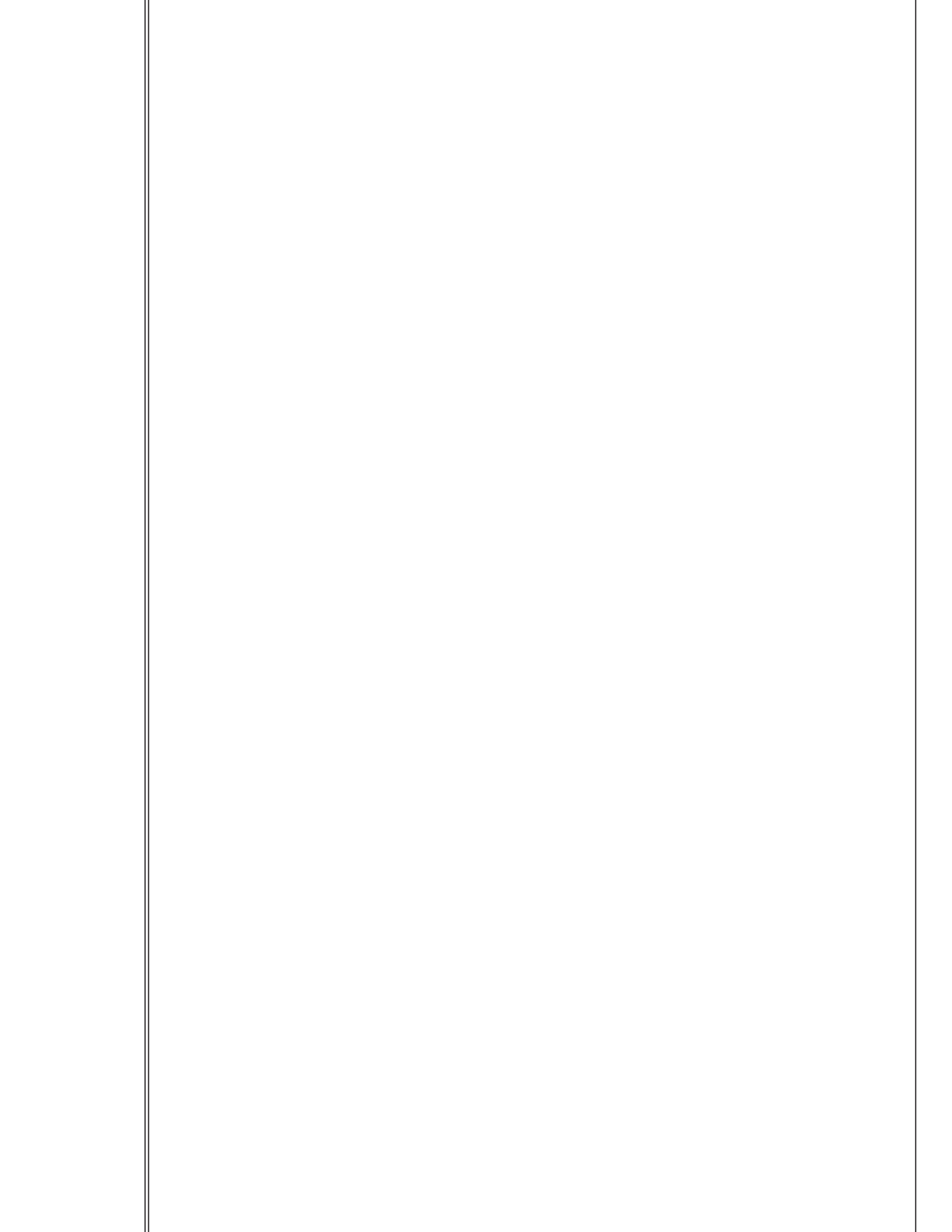

25 representative may designate, without the service of a subpoena.
