The National Do Not Call Registry

The National Do Not Call Registry provides an easy and efficient way for consumers to tell companies they don't want to receive most telemarketing sales calls. Robocalls that are sales calls are illegal whether a number is on the Registry or not, unless the caller has written permission from a consumer.

Since its inception in 2003, the Registry has continued to grow. As of September 30, 2011, there were 211 million active registrations. Consumers can register multiple phone numbers on the Registry by registering online at donotcall.gov or by calling 1-877-382-7373. For more information, visit www.donotcall.gov.
