Re: Unsubstantiated Claims for Opavirus Prevention or Treatment

To Whom It May Concern,

This is to advise you that FTCass has reviewed your website at <a href="https://www.drbrownstein.com">https://www.drbrownstein.com</a> May 8, 2020. We have determent that you are unlawfully advertising that certain products sourvices that you seenline or in your clinic treat or prevent Coronavirus Disease 2019 (COVID-19).

Some examples of Coronavirus treatmemprevention claims on your website include:

- x In marketing materials title&Coronavirus: What to Do,ÿou claim that intravenous therapies you provide can the cure COVID-19: "Conventinal medicine has little to offer to prevent or treat connavirus infections... It is time you to take the initiative and learn what other therapies are out there My last recommendation is to work with a holistic doctor who can give you nutrient IVs when you become ill. Vitamin C, hydrogen peroxide, and ozone IVs can helpone suffering from an infection. At my office, The Center for Holistic Medicine, we have seen the positive results a holistic approach to combatting viruses can provide."
- x In marketing materials titled "Coronavirul Marketing of an infection it is necessary for supplementationis essential to not only fighting of an infection it is necessary for proper immune system functioning. There is no acteria, virus, parasite or fungus that is known to be resistant to iodine. . . I suggest taking 25 mg/day as a daily dose and more (sometimes 50-100 mg/dat/) the first sign of an illness."

- x In marketing materials titled "Corawrirus: What to Do," you claim,First, it is important to maintain optimal levels of nutrients, particularly vitamins A, C, and D. Most people have suboptimal vitamin AdaC levels. Both of these nutrients have antiviral abilities and are able to support immenune system when it is under viral attack. If you are not ill, I suggest taking 3-5,000 mg/dxivitamin C. At the first sign of an illness, I would suggest taking 1,000 mg/houiludiarrhea develops, then back off for a time period. For vitamin A, I suggest ngi5,000 Units/day if you are not sick and 100,000 Units/day for four days at the first sign of an illness... Also, vitamin D is very important for fighting infections. I suggest,the onset of an illness, taking 50,000 IU of vitamin D3/day for four days."
- x In marketing materials titled "Conavirus Part II," you claim:

"At my office, we find great success with **dg**i IV nutrient therapy when our patients are ill with a viral or bacterial iffection. I received a note from physician colleague of mine (a "Yooper") who, at my request, gave hiertisa hydrogen peroxide IV and recovered from the flu in a day. Intrænous vitamin C, glutathionænd ozone are other therapies that also help with viral infections.

Holistically, there are a lot of things to for a viral infection like coronavirus. Conventionally, there is the to offer. My best suggestion? Become a patient at the Center for Holistic Medicie. We have many safe article the therapies to treat viral, bacterial, parasiticand yeast infections."

- x In marketing materials titled "85 COVID **Rea**nts at The Center for Holistic Medicine: Zero Hospitalizations and No Deaths," yo**aid** that your "protocol of using vitamins A, C, D, and iodine" and "intravenous neath therapy" should be "the first-line treatment provided in any COVID patient."
- x In marketing materials titled "85 COVID Rents at The Center for Holistic Medicine: Zero Hospitalizations and No Deaths," you in that your vitamin-based protocol "was sufficient for the majority of our COVID paties. I (and my partners) have no doubt that the vast majority of COVID patients would a deterioration of heir symptoms if they started this protocol the outset of symptoms."

- x In marketing materials titled "85 COVID Rents at The Center for Holistic Medicine: Zero Hospitalizations and No Deaths" you practice, "In my blogs, I encouraged people to take high doses of vitamins A, C, D, and ine at the first sign of an illness. In our practice, this was sufficient for the majority our COVID patients.... However, some became more ill or did not start the osapplements early enough into their illness. Those patients needed addited holistic therapies. These included nebulizing hydrogen peroxide and iodine along withtravenous nutrient therapieTo protect our staff and healthy patients, we direct treat sick COVID patients inde my office. We were gowning up and meeting our patients at the toan obile at the backer our building and administering IVs and ozone the pries. Some of these patients were very sick. So far, they all recovered."
- x In marketing materials titled "85 COVID **Re**nts at The Center for Holistic Medicine: Zero Hospitalizations and No Deathsout claim of people sick with COVID-19:

"Having them increase the frequency of nlexing hydrogen peroxidand iodine helped them all. Some of the sickest were addisenebulize every hour or two for a short period. IV therapies and ozone treatments have helped many.

This therapy has worked for helping COVIDtipeats. It is sad that hospitalized COVID patients are not given the propertritional support when theyre admitted. In a perfect world, I would immediately start an loff vitamin C and begin nebulizing any hospitalized COVID patient with hydrogen perdexiand iodine. I am sure that would markedly lower the need from echanical ventilation."

x In marketing materials titled "85 COVID Rents at The Center for Holistic Medicine: Zero Hospitalizations and No Deaths," you orlathat "[I]ike most holistic therapies, the earlier they are started in a diseascoess the better they perform. THE FIRST SIGN OF A VIRAL ILLNESS I ENCOURAGE MY PATIENTS TO START MY

long term patient, Andre from Boston, [diagnosed as COVID positive. Andre had a fever, severe diarrhea, and body acheswhere painful to the touch. Watch Andre's emotional testimonial as he talks aboust heicovery by strengthening his immune system with high doses of vitamins A, C, D & dine, nebulization, as well as at-home ozone therapy administered by his wife."

- x In marketing materials titled "There Is IStilope Out There-Miss Edabeth: 'Now that I am nebulizing properly I feel 95% better! you present a video testimonial from a woman named Miss Elizabeth. You claim, est my patient Miss Elizabeth. She & her family had COVID-like symptoms to include vere headaches treme difficulty breathing. Elizabeth talks about herovery through proper nebulizing with H202 solution and Lugol's 5% iodine. Wash her testimony to learn more."
- x In marketing materials titled "There isilsHope Out There-Bandon: 'I Didn't Really Break My 102 Fever for 4 or 5 Daysyou present a video testimonial from a man named Brandon. You claim, "Check out interview with COVID patient, Brandon, who is a paramedic. He experienced fact, body aches, high fever, followed by a shortness of breath. Watch Brandon's testinal bonin his progress after administering to himself a Super C IV, followed by supplementatiwith high doses of vitamins A, C, D & iodine."

It is unlawful under the TC Act, 15 U.S.C. § 4et seq. to advertise that a product or service can prevent, treat, or cure hurdispease unless you possess competent and reliable scientific evidence, including, when propriate, well-contited human clinical studies, substantiating that the claims are attube time they are ade. For COVID-19, no such study is currently known to exist foethroducts or services identified above. Thus, any Coronavirus-related prevention or treatmetatims regarding such products or services are not supported by competent and reliable sticic evidence. You must immediately cease making all such claims.

You are also advised toview all other claims for our products and immediately cease making claims that are not supported by etempand reliable scientific evidence.
