To Whom It May Concern:

This is to advise you that on September 2020, FTC staff reviewed your social media websites atwww.facebook.com/GotaysGroupSystemndwww.facebook.com/Cebilon-Puerto-Rico-57325116973268,7Where you direct consumersdontact you via telephone to purchase the aura Cebilon water filtration system. We have the remined that you are unlawfully advertising that certain products prevent or treatornavirus Disease 2019 (COVID-19).

Some examples of Coronavirus prevention or treatment daimade on your social media websites include the following:

- x In a Facebook post, posted https://www.facebook.com/GotaysGroupSystem March 26, 2020, you share an image that includes a depict an aura Cebilon water purifier and state: "Gotay's group system viene atacando duro al coronavirus!!! Con la gran oferta el 2x1. No dejes que el coronavirus te quit édicidad y la de tu familia tambien[.] Mantengase sano usted y su familia. Haci purifica tu agua y purifica tu aire con GOTAY'S GROUP SYSTEM mataos el virus!!! 787-385-3418."
- x In a Facebook post, posted https://www.facebook.com/GotaysGroupSystem March 31, 2020, you state: "No dejes q el Coronausi Afecte tu hogar tomando Agua alkalina proteges los tuyo; and share an image that includes lephone number and a depiction of an aura Cebilon water purifier.

x In a Facebook post, postedwww.facebook.com/Cebilon-Puerto-Rico-5732511697326876n March 31, 2020, you state: "Vamos a matar el Corana [sic] Virus juntos con GOTAY GROUP SYSTEM=CEBILON AURA P.P. and share an image that includes a telephone numbaerd a depiction of an aucebilon water purifier.

It is unlawful under the FTC Act, 15 U.S.C. § ett1seq. to advertise that a product can prevent, treat, or cure human disease unlesspossess competent and reliable scientific evidence, substantiating thatetblaims are true at the time they are made. For COVID-19, no such study is currently known to exist for threeduct identified above. Thus, any coronavirus-related prevention or treatmentaims regarding such product not supported by competent and reliable scientific evience. You should immediately asse making all such claims.

You are also advised to rew all other claims for your pducts and immediately cease making claims that are not supported by cetept and reliable scientific evidence.
