To Whom It May Concern:

This is to advise you that FTCast has reviewed your website at https://www.hawaiinaturopathicretreat.com onyMa3, 2020. We have determined that you are unlawfully advertising that certain products or serviceseppent or treat Coronavirus Disease 2019 (COVID-19).

Some examples of Coronavirus prevention treatment claims nyour website include the following representations on appaidled "COVID-19 Testing and Prevention":

- x You claim: "We've created several immulbeosting packages toelp you protect yourself against the coronavirus.... Reversprewent chronic illness and strengthen your immune system at your tour pathic cliric in Hilo."
- x Under the heading "Immune StrengtheonTreatments for Coronavirus Protection," you claim: "Strengthen your immune syst and build up your defenses for the future, not only to prevent coronavirus bothelp you cope better if you do get contaminated with the virus. To take your immune support one step further, you can take specific measureliske vit D injections, vit C intravenous infusions, and by taking supplements like vit D,zinc and vit C at therapeutic doses for boosting your immune system.

For COVID-19, no such study is currently known to exist for threducts or services identified above. Thus, any coronavirus-related prevention or treatmetaims regarding such products or services are not supported by competent and reliablen sidice evidence. You must immediately cease making all such claims.

You are also advised towiew all other claims for products and services and immediately cease making claims there not supported by competent and reliable scientific evidence.
